All documents must be current (with exception of Australian passports expired within the last two years but not cancelled) and contain the applicant's full name and date of birth and/or residential address.

Option A

One primary photographic identification document. OR

Option B

- · One primary non-photographic identification document, and
- One secondary identification document. OR

Option C (foreign identification documents)*

- International passport (must contain a photo, full name, date of birth and signature), and
- One secondary identification document (must contain full name and residential address)

*Passport must be current and foreign documents must be in English or be accompanied by a NAATI approved translation.

How to lodge your application at Australia Post.

Primary photographic identification document:

- Driver's licence or learners permit (Australian only)
- Australian passport (current or expired within the last 2 years)
- Government issued Proof of Age card (Australian only)

Primary non-photographic identification document:

- Birth certificate (Australian only)
- Citizenship certificate (Australian only)
- Centrelink Benefits Card

Secondary identification document (Australian only)

- Centrelink statement issued within the last 12 months
 Local government rates notice or utilities bill (electricity,
- gas or water) issued within the last three months • A notice issued by a school principal within the last 3 months

- Student card from school currently attended for a person under the age of 18
